Seventy-five years ago this year, from the ashes of World War II, under the shadow of the very worst of humanity, the Universal Declaration of Human Rights (UDHR) was born. We hope you engage with us in thinking deeply about the various manifestations and structures of violence and State violence, and the ways in which rights violations affect not only the individuals and communities targeted, but also create reverberations of harm for all of us.

We hope to build the connections between human rights in Malaysia and across our borders – connecting the dots between our struggles, and practicing solidarity with people across the globe.

Our world is ours to make. Let us be brave in our imagination, bold in our ability to think beyond the restrictions of oppression, humble in our willingness to listen, tender in our building of communities, open in our expressions of solidarity. May we be seeds, planting visions of a future that is just, loving, and a celebration of human rights for all. May we be gardeners in this collective dream, for the world we seek to make.

To all speakers, facilitators, artists, administrative and logistics teams, volunteers, musicians, janitorial staff, emcees, sound/tech staff; our friends, families and loved ones for their support and patience; to Amnesty colleagues in Malaysia and across the globe, human rights defenders in Malaysia and the countless named and unnamed activists who do the relentless work of righting wrongs, inspiring our learning and imagination, and building better worlds – our love & thanks to you. DEMAND FOR JUSTICE AT OUR WRITE FOR RIGHTS BOOTH!

For over 20 years, Amnesty International's annual Write for Rights campaign has transformed the lives of people whose rights have been wronged. Using the power of their words, Write for Rights supporters have united behind a common purpose: together, we can change lives for the better.

This year the campaign features people from around the world, all connected because their human rights have been violated. Some by their governments, others by the police, or even by big corporations. All because of who they are and what they do.

The individuals that AI Malaysia are campaigning for this year are Ana Maria from Brazil, Thapelo Mohapi and the Abahlali baseMjondolo movement in South Africa, Maung Sawyeddollah from Myanmar, and Rocky Myers from the USA.

At the booths, attendees will learn about these individuals and their stories, and write them letters of support and solidarity, sign petitions and write letters to relevant authorities to demand justice and accountability.



JUSTICA PARA PEDRO HENRIQUE

Ana Maria Santos Cruz - Brazil

Pedro Henrique was an activist who organized "Walks of Peace" in Tucano, Bahia, Brazil, bringing people together to speak out against police abuses. His activism was met with threats and violence from the police. In December 2018, Pedro Henrique was shot 8 times in the head and neck by three hooded men. He died, aged 31. The police officers suspected of the killing are still working and a trial has yet to begin. Despite her grief, Pedro Henrique's mother, Ana Maria, is bravely fighting for justice for his death.

Maung Sawyedollah - Myanmar

Maung Sawyeddollah was 15 when Myanmar's military unleashed a campaign of killings and violence against people from the Rohingya ethnic group. Incitement circulated on Facebook, and amplified by the platform's algorithms, fed into these attacks. Fearing for their lives, Sawyeddollah and his family fled to Cox's Bazar refugee camp in Bangladesh. Now, Sawyeddollah and others from his community are calling on Meta, owner of Facebook, to pay reparations for its role in the atrocities, including funding for educational programmes in Cox's Bazar.

Demand Meta provide an effective remedy to Sawyeddollah and Rohingya communities.



Thapelo Mohapi and the Abahlali baseMjondolo movement — South Africa

Thapelo Mohapi loves listening to jazz and supporting his favourite football teams. But since 2021 he has been in hiding because

of threats to his life. He is being targeted because he is a leader of Abahlali baseMjondolo (AbM), a grassroots movement working to improve the lives of people in South Africa, including eKhenana – a community which suffers from many challenges, including economic insecurity, lack of access to adequate housing and police brutality. In 2022 alone, three AbM members were killed in eKhenana.

Tell the police to thoroughly and effectively investigate the harassment and killings of AbM members.



Rocky Myers - USA

Rocky Myers, a Black man with an intellectual disability, has spent three decades on death row in Alabama for murder. Assigned ineffective legal representation, Rocky was convicted following testimonies blighted by inconsistencies and alleged police pressure.

Sentenced to death by a judge who imposed a death sentence against the jury's wishes, Rocky was abandoned by his post-conviction lawyer, meaning he missed key dates for his appeal. Now he needs your help.

Tell the governor of Alabama to grant clemency to Rocky Myers.

Human Rights for All Photo Exhibition

Human Rights for All is a 20-piece photo exhibition collaboration between Amnesty International France and the prominent photo agency Magnum Photos. For this 'We Make Our World' event, we have selected 12 photos to be exhibited at the KL & Selangor Chinese Assembly Hall.

Magnum was created in 1947 by four world renowned photographers Robert Capa, Henri Cartier Bresson, George Rodger and David "Chim" Seymour as a cooperative agency whose aim was to document with photographs, and make accessible to all, the facets and the reality of an ever-changing world.

For the 60th Anniversary of Amnesty International, Amnesty International France partnered with Magnum to create an accessible and affordable photo exhibition that would promote Human Rights For All through a retrospective of iconic Magnum photographs documenting 60 years of mobilisation for human rights.

The photos in this exhibition reflect the spectrum of human rights issues that Amnesty has worked on over six decades, and is a reminder of the universality of the struggle for human rights, peace, justice and dignity for all.



Hope & Sorrow: Photography Exhibition on The Death Penalty

This exhibition explores how the death penalty gravely impacts relatives of those on death row – as "secondary victims" – through the experiences of three families whose loved ones were sentenced to hang in Singapore.

The photo display has been organized by Amnesty International to mark the 2023 World Day Against the Death Penalty on 10 October, in an effort to contribute to informed debates on this cruel punishment that can help bring about its global abolition.

Amnesty International is solely responsible for the exhibition, but our gratitude goes to several committed people who have made it possible. First and foremost, we thank the families of Nazeri bin Lajim, Pannir Selvam Pranthaman and Kalwant Singh a/l Jogindar Singh for allowing us to share their stories and expose very difficult and intimate moments of their lives in the shadow of Singapore's gallows. This exhibition is dedicated to them and all others who have a loved one on death row or who had them taken away in the name of vengeful "justice".

Photo reporter Piero Zilio generously granted permission for us to use photographs he took in Singapore and Malaysia, which constitute the majority of the display. He also shared much of the information described in their captions. Other photos, taken in Kuala Lumpur in Malaysia, were kindly offered by Asyraf Abdul Samad.

We are also indebted to the Transformative Justice Collective, who support the families of those on death row in Singapore and raise awareness of the country's cruel use of the death penalty.
